7	that ch	anges to the organizational structure are often made to focus efforts on the organization's core
8	compe	tencies and to minimize the use of resources elsewhere; and
9		WHEREAS, the process of bringing the actions of an organization's business units in line with the
10	organiz	ration's planned objectives is a priority of the CCU and GPA's Management; and
11		WHEREAS, the timeline from start to finish for the reorganization will take approximately five to
12	six mor	nths to complete (see Exhibit A), this includes the following scope of work:
13		1. Preliminary Review
14		2. Assessment of Information
15		3. Finalize Report
16		4. Publication Notice
17		5. Distribution of Written Notice of Reorganization Plan Provided to Employees
18		6. Posting of Plan and Proposals Posted in GPA Website
19		7. Public hearing
20		8. CCU Meeting
