#### **RESOLUTION NO. 2016-40**

### AUTHORIZING EXPENDITURES FOR WORK PERFORMED BY TEMES ON THE COMBUSTION TURBINE AND DIESEL POWER PLANTS

WHEREAS, the Guam Power Authority (GPA) has contractual agreements with Taiwan Electrical and Mechanical Engineering Services, Inc (TEMES, Inc.) for the Piti #7 Combustion Turbine power plant and the Performance Management of Cabras 1&2; and

 WHEREAS, GPA requested for technical assistance from TEMES for the combustion turbine and diesel power plants to expeditiously return the units to service in support of the IWPS generation shortfall resulting from the loss of Cabras 3 & 4; and

WHEREAS, the Yigo and Macheche combustion turbine units were derated and the Manenggon, Talofofo, and Tenjo diesel units were out of service which impacted GPA's ability to meet system demand; and

WHEREAS, TEMES reconditioned the turbocharger at Manenggon, supplied a VSV controller at Macheche, as well as an accelerometer, filters, bellows, electric hoists, and other parts for the combustion turbine and diesel plants; and

WHEREAS, the Manenggon, Talofofo, and Tenjo units were returned to service through the efforts of TEMES and systems at the Macheche and Yigo combustion turbines were repaired; and

WHEREAS, GPA is now requesting approval to reimburse TEMES for services and parts TEMES obtained on behalf of GPA in the amount of \$518,629.63; and

WHEREAS, GPA will utilize revenue Operations & Maintenance funds for these costs.

NOW, THEREFORE, <u>BE IT RESOLVED</u>, by the CONSOLIDATED COMMISSION ON UTILITIES, the GOVERNING BODY of the GUAM POWER AUTHORITY as FOLLOWS:

After careful consideration, the Consolidated Commission on Utilities finds the expenditures
for the repairs of the combustion turbines and diesel generators to be reasonable and
prudent.
