## GUAM CONSOLIDATED COMMISSION ON UTILITIES GPA RESOLUTION 2017-04

**GWA RESOLUTION 17-FY2017** 

RELATIVE TO THE AUTHORIZATION FOR GUAM POWER AUTHORITY AND GUAM WATERWORKS AUTHORITY FOR AUTHORIZATION TO SEEK LEGISLATIVE APPROVAL TO CONTRACT FOR HEALTH GROUP INSURANCE FOR THEIR EMPLOYEES AND RETIREES

WHEREAS, the Consolidated Commission on Utilities has undertaken initiatives to identify opportunities for savings for the ratepayers of Guam; and

WHEREAS, GPA and GWA have recognized that an opportunity for savings exists if GPA and GWA are authorized to procure separate health group insurance for their employees, and retirees, based on the experience of the Judiciary, which has procured its own health group insurance; and

WHEREAS, the CCU has reviewed the proposed draft legislation which would authorize GPA and GWA to procure separate group health insurance, and the CCU recognizes there is an opportunity for savings; and

NOW, THEREFORE BE IT RESOLVED, the following policy is adopted by the Consolidated Commission on Utilities;

1. The General Manager of the Guam Power Authority and the General Manager of the Guam Waterworks Authority are authorized to submit the draft legislation to the legislature for consideration, which if enacted would authorize GPA and GWA to procure separate health group insurance for its employees and retirees.
