Justification for the new position:

The Guarn Waterworks Authority (GWA) has determined a need to create the Utility Compliance Inspector I, II, and Leader positions to carry out its mission towards providing "Better Water Better Lives" to the people of Guam.

The Utility Compliance Inspector I, II and Leader will work under the general direction of the Assistant General Manager of Compliance and Safety and the direct supervision of a respective program's Manager to help manage GWA's wide range of regulatory activities. Programs include but not limited to the 2011 Court order (CO), the Federal Safe Drinking Water Act (SDWA), Guam Primary Drinking Water Regulations (GPDWR) and their amendments including the Ground Water Rule (GWR), Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR); the Clean Water Act (CWA); the Clean Air Act (CAA) and pursuant to further compliance to correct the "Findings of Significant Deficiencies in Guam Waterworks Authority's Public Water Systems. The positions also require awareness of the Occupational Safety and Health Act (OSHA).

The creation of the Utility Compliance Inspector series is for the efficient and effective performance of duties and functions of the regulatory and compliance programs of the Guam Waterworks Authority. The essential functions of these positions include, performing sampling, inspection and investigation duties for compliance with Federal, and Guam regulations.

In order to protect the public, we need to perform sampling, inspection and monitor for illegal or incorrect infrastructure to successfully improve the safety, efficiency and the reliability of the water and wastewater facilities. This will also result in improved services to our rate payers.

Analysis of similarities and differences between the positions to be created and the positions listed pursuant to 4GCA §4101.1:

The above positions are new for GWA. The duties and responsibilities of Utility Compliance Inspector series positions will provide a variety of technical work to successfully improve the safety, efficiency and the reliability of the water and wastewater facilities. The position also includes the capacity to ensure the compliance with all applicable established laws, policies, regulations and principles of the program. These positions were compared and created in line with other inspector positions with water and wastewater utilities in other municipalities.

Compensation:

The proposed pay range is demonstrated to be in compliance with 4GCA §6301. Also, the minimum and maximum range of compensation will be in accordance with the Strategic Pay Methodology when the job description and qualification factors are taken into consideration and the new position is slotted. The resultant new pay grade under the implemented compensation structure and per annual is as follows:

The Utility Compliance Inspector Leader leads and performs various types of inspection work under the general direction of the Assistant General Manager (AGM) for Compliance and Safety and the direct supervision of a respective program's Manager to help manage GWA's wide range of compliance and regulatory activities.

The position may include supervision of lower level inspectors as delegated and assigned by the AGM or the respective Program Manager.

Performs a variety of highly skilled work to successfully improve the safety, efficiency and the reliability of the water and wastewater facilities and operations.

Issues for Decision

Resolution No.:

Relative to the Creation of the Utility Compliance Inspector Leader, Utility Compliance Inspector II, and Utility Compliance Inspector I positions at the Guam Waterworks Authority.

What is the project's objective and is it necessary and urgent?

The Guam Waterworks Authority (GWA) has determined a need to create the Utility Compliance Inspector Leader, II, and I positions to carry out its mission towards providing "Better Water Better Lives" to the people of Guam.

The Utility Compliance Inspector I, II and Leader will work under the general direction of the Assistant General Manager of Compliance and Safety and the direct supervision of a respective program's Manager to help manage GWA's wide range of regulatory activities. Programs include but not limited to the Federal Safe Drinking Water Act (SDWA), Guam Primary Drinking Water Regulations (GPDWR) and their amendments including the Ground Water Rule (GWR), Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR), the Clean Water Act (CWA) and the Clean Air Act (CAA) and pursuant to further compliance to correct the "Findings of Significant Deficiencies in Guam Waterworks Authority's Public Water Systems. The positions also require awareness of the Occupational Safety and Health Act (OSHA).

The creation of the Utility Compliance Inspector series is for the efficient and effective performance of duties and functions of the Guam Waterworks Authority. Performs sampling, inspection and investigation duties for compliance with Federal, and Guam regulations.

In order to protect the public, we need to perform sampling, inspection and monitor for illegal or incorrect infrastructure to successfully improve the safety, efficiency and the reliability of the water and wastewater facilities. This will also result in improved services to our rate payers.

Where is the location?

The Utility Compliance Inspector series will be organizationally located within the Compliance and Safety Department, under the general direction of the Assistant General Manager for Compliance and Safety and direct supervision of a respective program's manager.

How much will it cost?

There is no cost to create the position.

When will it be completed?

Public Law 28-159, Section 7.0.3 (c) requires GPA and GWA to post a petition on their websites for ten (10) days (not including Saturdays, Sundays and government of Guam holidays). After the 10 days posting, the petition can then be forwarded to the CCU for their disposition at any regularly scheduled meeting. GWA has met the posting requirements.

Additionally, Guam law requires notice of such posting to each newspaper of general circulation and broadcasting station which airs regular news programs within Guam.

What is the funding source?

GWA will certify funding for the position available for the filling and retention of its certified, technical and professional newly created position. The funding of this position does not have an impact on the General Fund.

Utility Compliance Inspector Leader

NATURE OF WORK IN THIS CLASS:

The Utility Compliance Inspector Leader leads and performs various types of inspection work under the general direction of the Assistant General Manager (AGM) for Compliance and Safety and the direct supervision of a respective program's Manager to help manage GWA's wide range of compliance and regulatory activities.

The position may include supervision of lower level inspectors as delegated and assigned by the AGM or the respective Program Manager.
