1 **RESOLUTION NO. 2017-48** 2 AUTHORIZING THE MANAGEMENT OF THE GUAM POWER AUTHORITY TO PETITION THE PUBLIC UTILITIES COMMISSION FOR THE EXTENSION OF THE DIESEL FUEL OIL NO. 2 SUPPLY CONTRACTS 3 4 WITH MOBIL OIL GUAM, INC (MOGI) AND IP&E 5 6 WHEREAS, the three (3) year base period contracts for the Diesel Fuel Oil No.2 Supply (GPA-029-14) between the Guam Power Authority (herein after referred to as "GPA") and Mobil Oil Guam, Inc. (herein 7 8 after referred to as "Mobil") and between GPA and Isla Petroleum Energy, Inc. (herein after referred to as 9 "IP&E") will expire on December 31, 2017; and 10 WHEREAS, GPA intends to extend the contracts for Mobil and IP&E for a period of one (1) year to commence on January 01, 2018 and expire on December 31, 2018; and 11 12 WHEREAS, in the aftermath of the Cabras 3&4 incident, the total annual GPA plant diesel consumption 13 (Exhibit A) has significantly increased from approximately 3 million gallons (80,000 barrels) to close to 34 million gallons (800,000 barrels) after FY2015; and 14 15 WHEREAS, the total annual projected requirement of diesel supply for the power plants is 895.066 16 barrels and the daily consumption ranges from approximately 1,000 barrels to up to 6,000 barrels a day; and 17 18 WHEREAS, the estimated premium fees for Mobil and IP&E for the one year contract extension is 19 \$10,922,124; and 20 WHEREAS, the estimated cost of fuel less premium fees, consistent with the LEAC average ULSD cost is approximately \$66,503,374 for the one year contract extension; and 21 WHEREAS, the projected costs for ULSD to include premium fees is \$77,425,498; and 22 WHEREAS, GPA is requesting approval of contract extensions with Mobile and IP&E for one year to 23 commence on January 01,2018 and expire on December 31, 2018. 24 25

33	2. The Guam Power Authority is hereby authorized to enter into a 1-year contract extension with
34	IP&E for the supply and delivery of Diesel Fuel Oil No 2.

36	3. The General Manager of the Guam Power Authority is hereby authorized an increase in obligating
37	authority to \$77,425,498 for a one year extension of the contracts for ULSD over \$750,000.00 and
38	to execute such agreements and documents necessary with Mobil and IP&E.
