RELATIVE TO THE AUTHORIZATION FOR THE GUAM POWER AUTHORITY & GUAM WATERWORKS AUTHORITY TO ENTER INTO A CONTRACT FOR MERCHANT BANKING SERVICES

WHEREAS, GPA & GWA received a notice from our current vendor, Data Management Resources (DMR), that they cannot provide merchant banking services effective January 31, 2016 and they are working to extend the deadline with their processor; and

WHEREAS, GPA & GWA determined that the merchant banking services is a critical service for GPA and GWA and a new RFP for merchant banking services for one year with four options, and with each option to extend for a one-year period is needed; and

NOW THEREFORE, BE IT RESOLVED, by the Consolidated Commission on Utilities, subject to the review and approval of the Guam Public Utilities Commission, as follows;

1. The General Manager of the Guam Power Authority & Guam Waterworks Authority is hereby authorized to issue an RFP for the one year contract period with four options, and with each option to extend for one-year period for GPA and GWA.
