RATIFICATION OF ADDITIONAL EXPENSES FOR AGGREKO'S TEMPORARY POWER SERVICES

6 **WHEREAS**, the Guam Power Authority (GPA) experienced a major failure of its base load
7 units at the Cabras 3&4 power plant when an explosion and a fire occurred in the Cabras 4
8 engine on August 31, 2015; and

9 **WHEREAS**, the power system has lost about 79 MW of base load capacity placing GPA in
10 the position of having difficulty meeting system demand upon an additional base load or large
11 emergency unit outage; and

12 **WHEREAS**, the Authority has contracted Aggreko under GPA-RFP-15-008 to provide for
13 40 MW capacity of leased generation for the first year to mitigate part of the capacity loss in
14 order to maintain other base load units; and

15 **WHEREAS**, GPA had approved change orders for the total amount of \$540,213.90 for
16 additional work necessary for the plant construction completion and operation (Exhibit A); and

17 **WHEREAS**, the total change order amount had exceeded the GM's authority of
18 \$250,000.00; and

19 **WHEREAS**, GPA is requesting for approval to ratify the additional expenses in the
20 amount of \$540,213.90. Expenses were deemed immediately necessary in order to expedite
21 the commissioning of the units due to generation capacity shortfall.

22 **NOW, THEREFORE, BE IT RESOLVED**, by the CONSOLIDATED COMMISSION ON UTILITIES
23 as follows:

29 Commission attests the adoption of this Resolution.




