The meeting was called back to regular session.

The Chairman said we are back in open session and said to commissioners we have an agreement and have selected a candidate - Candidate A. We now will discuss salary and will need delegation to make an offer to the candidate and upon acceptance will come back to the Commissioners with an update.

Comm. Sanchez said that we have been migrating all employees' pay over time to gradually move them up to the highest percentile of what we can balance between what they deserve and what ratepayers can afford. We do regular wage surveys to see where we are for the entire employee base and the current goal is 20 percentile.

Based on the recent survey I would like to make a motion that we offer Candidate A pay at the 20th percentile giving the candidate time to prove themselves and grow to the 25th percentile. The amount at the 20th percentile, that is the average pay for 20% of the attorney's working for similar size water utilities, is \$125,620.

Comm. Sanchez motioned to offer Candidate A the base pay of \$125,620 and all other standard benefits that accrue for a government employee that flows from this base pay; second by Comm. Santos.

Comm. Duenas said he agrees with the motion; he said the job is worth something and we are migrating to the 50% percentile and this job is worth this amount of money.

Relative to reviews there was discussion if there should be a clause included in the contract relative to reviews and whether that annual review would be made public. Comm. Duenas said he liked the language contained in the CCU Rules & Regulations. Comm. Limtiaco said based on the interview responses to questions and based on the review, if the candidate responded affirmatively to having her review doe in open ession he would like this incorporated into the employment agreement. Comm. Santos reiterated what Comm. Limtiaco is trying to say – that if the candidate has agreed to disclosing the annual review publicly then we put this in the contract. If the candidate says no then; it will not be disclosed publicly. He said of the 7 employees that CCU hires, only the

GM Bordallo is the ask of making the review public is a condition of employment stating his concern that it may be a deterrent. The Commission said that it will not be a condition but will only pose the option.

The Chairman provided original agreement copy and candidate's counter offer. In addition the Chairman made available a combined redlined copy of the original agreement v. candidate's counter offer [in track changes] so the Commission can easily see where the changes were made.

Comm. Sanchez stated that at the last meeting during open session on August 4, 2021 it was motioned and seconded to offer the candidate a salary of 125,620.00. He asked if the candidate accept the salary as offered. Comm. Duenas confirmed yes, the salary as specified was accepted by the candidate.

Comm. Limitaco said there were changes that the candidate edited so she didn't accept the original language so the Commission needs to address that. Comm. Limitaco said it is important that the Commission understand what was submitted originally and what changes were made by the candidate. Comm. Santos recommended to review the agreement one section at a time and vote on each change made; all agreed.

Section 1 – Comm. Sanchez said the candidate proposed a start date of September 13, 2021. All agreed it was acceptable.

Section 2 – Candidate used word "their" effort – there was no objection. Comm. Martinez questioned the social activities clause and asked for clarification. Comm. Sanchez clarified that outside of work the candidate can do as she pleases except to participate with activities that conflict with duties as that of an attorney. Comm. Limtiaco as example said she could not practice law but if she wants to open a convenience store she could do so. All agreed this was acceptable.

Comm. Martinez asked clarification on this section relative to 2.05 – during the term of the agreement "shall receive direction from GM and report to the GM"; he then mentioned the performance eval on 4.04 requires that CCU do a performance evaluation, he asked if management also should do a performance eval since the candidate will be reporting to them. Comm. Limtiaco said key metrics will be identifed and discussed between the candidate and the GM in advance and their evaluation will be based on these specifics upon evaluation; the Commission also will base their evaluation on how well the candidate performed against these same key metrics.

Comm. Martinez relative to benefits asked if the candidate would be considered a classified or contract employee. Comm. Sanchez said that the candidate would be eligible for all standard GovGuam benefits.

It was discussed that the current flow of the agreement was skewed and needed to be revisited because it does not flow well. After some discussion it was decided to amend the sections to reflect the following: Section 3 Compensation, Section 4 Benefits, Section 5 Evaluation, Section 6 Termination / Dismissal.

Next steps were discussed – the Chairman will rewrite the agreement per changes made today, circulate it to the Commission who will verify for correctness and adopt the changes as CCU's counter offer to the candidates counter offer.

Chairman asked of a motion to authorize the chair to present the CCU counter offer to candidate.

Comm. Sanchez motion to adopt the changes made to the GWA Staff Attorney Counter Offer Agreement, at the CCU Special Meeting of August 17, 2021, as the CCU Counter Offer to the GWA Staff Attorney Candidate; and to authorize the Chairman to present the CCU Counter Offer Agreement to the Candidate; and if the candidate accepts, the process of selecting a GWA Staff Attorney would be complete. The motion was seconded by Comm. Santos. The vote was unanimous, 5 ayes, and the motion carried.

Relative to the Salary segment – it was discussed to strike the language "shall be kept competitive" and to stay with the original language "based on annual performance evaluations as prescribed by CCU policy"; all agreed. It was also mentioned to add employee will be paid on regular GWA paydays.

Relative to personal leave it was mentioned that personal leave needs to be defined. It was decided to keep the original language of 30 days leave.

Relative to the segment regarding Section 15 " no party would be deemed as drafting this agreement" clause the Commission wanted legal opinion regarding this clause and its importance for inclusion.

Relative to Evaluation Option A and Option B as drafted by candidate, it was mentioned to make sure that candidate understands that Option A is choice of the Commission.

It was mentioned that if the candidate declines the revised agreement / counter then the selection process will continuation.

Comm. Sanchez motioned to recessed this meeting until 5 p.m. 8/24, 2021, second by Comm. Santos. The motion passed unanimously.
